Spaces will be reserved on a first-come, first-served basis. Assignment of spaces is at the sole direction of the -H Staff.

Only one (1) Vehicle for each Vendor will be allowed on the Fair Grounds each morning or evening and will be parked in the designated parking area during fair hours. Ample Commercial parking in the parking lot is set aside for Commercial Vendors.

FIRE ROADWAY BETWEEN THE BARNS AND EXHIBITORS WILL BE STRICTLY ENFORCED. NO COMMERCIAL VENDORS VEHICLES WILL BE ABLE TO PARK ON THE GROUNDS IN THAT AREA. VIOLATORS MAY BE ASKED TO LEAVE THE FAIR.

No personal checks will be accepted after July 29, 2017. Cash or Money Orders only will be accepted after that date.

TERMS, RULES & REGULATIONS FOR THE ATLANTIC COUNTY 4-H FAIR

All exhibits must be in place by 11:30 am each day and must be removed by 11:00 am on Sunday August 13, 2017 All exhibitors must maintain and leave their exhibit space clean and free of rubbish. **SET UP TIME SHOULD START NO SOONER THAN WEDNESDAY, AUGUST 9, 2017 AT 11:00 am.**

***ALL VENDORS/EXHIBITORS SHALL CHECK IN AT A DESIGNATED AREA AT WHICH TIME ALL INFORMATION ON FILE WILL BE VERIFIED AND YOU WILL BE DIRECTED TO YOUR SPACE.**

Breakdown of Exhibits is not permitted until the FINAL EVENT ON STAGE IS COMPLETED ON SATURDAY NIGHT. FAILURE TO ADHERE TO THIS WILL JEOPARDIZE YOUR ACCEPTANCE AT FUTURE FAIRS.

Police and watchmen services will be furnished during the Fair but 4-H Fair Assoc. is not responsible for the exhibitor's wares or equipment.

General lighting will be furnished between 10:00 am and 12 midnight. Receptacles will be provided for the use of the exhibitor according to the following rate:

Use of 1000 watts or less provided at no charge. Additional fee of \$10 for each additional 500 watts.

Electric is available for use between 12 midnight and 10:00am (i.e. trailers) for an additional fee of \$25.00 to be paid at the signing of this contract. **No Generators will be permitted.** Momentary or intermittent power uses such as compressors, heat presses, etc. is considered "use" and will be charged for accordingly. Signing of this contract agrees to the above rates and the metering of use by the official 4-H Fair Assoc. Electrical Manager.

The Fair Association reserves the rights to reject displays or sales of any merchandise which will violate the 4-H charter. The following items are not allowed at the fair regardless of whether other fairs permit them. They are **NO DRUG PARAPHERNALIA (THIS INCLUDES CANDY CIGARETTES), KNIVES, WHIPS, CHAINS, GUNS (THIS INCLUDES ANY SUCH WEAPON THAT MAY SHOOT ANY TYPE OF OBJECT SUCH AS PELLETS, DARTS, ETC.) , HANDCUFFS, SILLY STRING, SNAPS, INVISIBLE INK, LASER LIGHTS, PAINT BALL EQUIPMENT OR SUPPLIES OR OTHER DISTASTEFUL ITEMS.** Any misrepresentation or fraud by exhibitors of products or goods or displays will not be tolerated and will result in the forfeiture of the right to exhibit at the 4-H Fair.

Noise nuisances will not be permitted in the exhibitor's space. Vendors or exhibitors are not permitted to leave their space to sell or display their products. This includes poppers and light sabers not to be sold.

The 4-H Fair Association will not be responsible for exhibitors against fire, accident, or any other cause. If an exhibitor desires any insurance coverage relating to exhibit, or persons concerned there at, they must obtain such coverage at their own expense.

Possession and/or use of alcoholic beverages or drugs are FORBIDDEN on the property of the David C. Wood 4-H center and Fairgrounds.

Spaces will be rented for three (3) days and are expected to be manned during the normal operating hours of the 4-H Fair. **Rental is for the space only. Tables and chairs are not available.**

No animals are permitted on the 4-H Fair grounds by the exhibitors. EXHIBITORS MUST WEAR SHIRTS even when setting up and breaking down.

SUBLETTING OF SPACE IS PROHIBITED. Anyone found in violation of this will be asked to leave the grounds and will result in the forfeiture of the right to exhibit at the 4-H Fair.

REFUND POLICY: Any cancellation received on or before July 18, 2017 will have full amount of money minus a \$ 15.00 service fee refunded. Any cancellation received after this date will receive **NO REFUND.**
